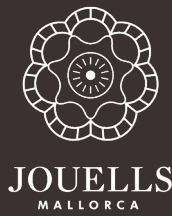

THE CONTROLLER, as controller for the website and in accordance with the provisions of regulations in effect on the protection of personal data, Regu-lation (EU) 2016/679 of 27 April 2016 (GDPR) on the protection of natural persons as regards the processing and free circulation of personal data, and by Act 34/2002 of 11 July 2002 on Information Society and Electronic Com-merce Services (LSSICE), has implemented all security, technical and organ-isational measures set out in Royal Decree 1720/2007 of 21 December 2007, (which implements the LOPD) to ensure and protect the confidentiali-ty, integrity and availability of the data entered.

All USER personal data collected in the various forms found throughout the web will be stored in an automated file owned by **Liberia Investments S.L.U.**

The purpose of processing is to provide the following services to the USER:

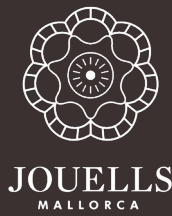

Commercial e-mail messages

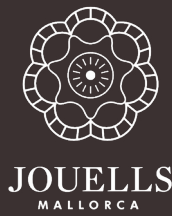

Changes in this Privacy Policy

This Privacy Policy may be modified at any time to adapt to new laws or by decision of the CONTROLLER.

In any case, whether the Privacy Policy has changed or not, USERS have the right to exercise the following rights:

1. Right to access personal data and receive confirmation about whether we are processing personal data concerning them or not.
2. Right to request the rectification of inaccurate data or, as the case may be, request their erasure when, among other reasons, the data is no longer necessary for the purposes they were collected.
3. Right to request restriction of processing of one's data, in which case we will only keep them for exercise or defence of legal claims.
4. Right to object to the processing of one's data in certain circumstances and for reasons related to their particular situation, data subjects.
5. Right to data portability



6. Right to withdraw previously granted consent, provided such with-drawal does not affect the lawfulness of previous processing based on such consent.
7. Right to lodge a complaint with a supervisory authority.

Minors
